

## **Rebuild Solano's Small Businesses Grant Program**

to be administered by the Workforce Development Board of Solano County & the Solano Small Business Development Center

### **Program Summary**

In an effort to support small businesses and employers facing financial impacts and layoffs from the novel coronavirus (COVID-19), the County of Solano, in partnership with the Workforce Development Board (WDB) of Solano County and the Solano Small Business Development Center (SBDC), has established the *Rebuild Solano's Small Businesses Grant Program*.

Utilizing \$2 million in Coronavirus Aid, Relief and Economic Security (CARES) Act funds, this program will provide microgrants to Solano County small businesses who are experiencing economic stress related to the pandemic, with the goal of preventing layoffs or closures and allowing small employers to effectively pivot operations in response to COVID-19.

### **Eligibility Guidelines**

Eligible applicants include for-profit businesses who:

- Are based in Solano County
- Have 50 employees or less
- Are in good standing with the State of California and the County of Solano
- Can demonstrate a need for funding due to the impacts of COVID-19

Awards will be given based on whether the above eligibility is met, the demonstrated need of the business due to COVID-19, and the quality of the application. Priority will be given to businesses that have less than 20 employees. Staff will consider whether businesses have received small business grants from other locally funded COVID-19 business investment programs in award decisions.

The WDB and SBDC, in partnership with cities and chambers, will provide technical assistance and targeted outreach to minority-owned businesses, industries that have been significantly impacted due to COVID, and communities that have received minimal small business investment to ensure equity in distribution of funds.

### **Grant Details**

With a \$2 million investment in Solano's small businesses and employers, the WDB anticipates the ability to provide micro-grants to approximately 400 businesses. Grants will be reimbursement-based on costs that meet allowable expenditures between the periods of March 1, 2020 and November 30, 2020.

Due to federal funding, selected employers must attest to Certifications and Assurances and complete the contract process before funds may be dispersed. Businesses will be required to submit brief summaries and proof of expenses before reimbursements are issued. Entities receiving an award may be subject to local, state or federal monitoring.

Examples of permissible activities will include, but are not limited to:

- Purchasing computer equipment or software that allows remote work capabilities
- Paying for services or tools to convert to online or outdoor sales or delivery
- Purchasing cleaning or sanitation supplies/services that reduce exposure and transmission per reopening guidelines
- Replacing product or inventory lost or spoiled due to COVID-19
- New marketing strategies to engage clientele
- Machinery or equipment needed to reduce exposure or pivot product sales
- Activities that address supply chain challenges or to acquire new bids
- Other creative approaches and strategies to reduce or eliminate the need for business closure or to pivot operations as a result of COVID-19.

Funds will not be allowed to be used to pay for employee wages or benefits, nor for rent or utilities.
